## INTRODUCTION

Just like all other role-players in South Africa, AfriForum is concerned about the increasing occurrence of crime at churches which threatens the safety of congregation members. It undermines the basic right to a safe environment, and one cannot simply stand by watching idly while the government and law enforcers maintain an indifferent attitude.

The fact that there is substantial unhappiness in the broader communities across the country about the conditions at and accessibility to churches in the country is understandable. The cause of and solution to this problem have however been discussed extensively and is not the purpose of this guide.

## OBJECTIVE

By publishing this guide, AfriForum wants to empower churches to act proactively by conducting an audit of the safety of both the church as well as its members, and by implementing measures to improve the safety of members in churches.

## PROBLEM STATEMENT

Incidents of crime in and at churches have made it clear that churches are not prepared for all the possible dangers they may be faced with. People in our communities should be able to live in a healthy and safe environment. This societal requirement cannot be fulfilled when churches are disrupted or threatened by crime.

AfriForum is of the opinion that a well-prepared church is a difficult target for criminal elements and that they would rather carry out their efforts in other ways and at other places. If they do however try to disrupt a church that is prepared, the risks and damages will be minimised, and timely action of stabilising elements will bring the situation under control more quickly.

## WHY ARE CHURCHES VULNERABLE?

In the past, the state honoured its responsibility with respect to the safety of communities and there was no need for security companies or other institutions to look after the safety of churches. Church leaders are

therefore not necessarily focused on analysing risks and implementing safety measures. As a result, this limitation with regards to security must be addressed urgently, as crime is on the increase.

## STRUCTURE OF THE GUIDE

The structure of this guide is intended to assist in assessing and improving your church's safety plans. A brief summary is provided of the different risks that have been identified at churches. A general assessment questionnaire offers the opportunity to focus on the more specific evaluation aspects of the individual risks on a tactical level. The answers to these evaluation aspects will allow you to determine whether your church is sufficiently prepared to handle the various risks. Should this not be the case, the list will clearly indicate to you in which areas your church security needs to be ramped up.

Break-ins, fires and medical incidents represent reasonably common risks for every church in the country, while the other risks are more dependent on local circumstances. Vehicle theft and armed robberies affecting churches and their members are also unfortunately becoming more common, although the active crime doesn't always occur on the church grounds. This manual therefore offers guidelines so that churches, their staff, and their members can be prepared for these types of risks.
